

**A RESOLUTION OF AFFIRMATION TO THE REPUBLICAN PARTY OF TEXAS  
IN FAVOR OF HARMEET DHILLON, AS REPUBLICAN NATIONAL COMMITTEE CHAIRWOMAN**

**WHEREAS**, Ronna Romney McDaniel has chaired the Republican National Committee (RNC) since January 2017; and

WHEREAS, under Chairwoman Ronna McDaniel's leadership, the GOP suffered successive losses of the US House of Representatives during the 2018 Midterm Elections, the Presidency and both houses of the US Congress during the 2020 Presidential Year Elections, and, despite barely winning the US House of Representatives, loss par representation in the US Senate during the 2022 Midterm Elections; and,

WHEREAS, the County Executive Committee is made up of the Precinct Chairs, who are the grassroots movement of the Republican Party of Bexar County (RPBC) – Texas, is committed to getting Republicans elected, to further advance the conservative agenda; and,

WHEREAS, Chairwoman Ronna McDaniels has failed the grassroots movement by not addressing the widely held concerns: election integrity, offensive lawfare in defending the constitutional legitimacy of the voting process and reclaiming constitutional order, lack of creative vision in building unity throughout the Party and attracting new voters, holding our politicians accountable to the grassroots and mandates of the voters, rather than beholden to the consultants and lobbyist; and,

WHEREAS, a viable candidate in Harmeet Dhillon, who has the experience and vision in addressing the aforementioned concerns, is seeking the position of RNC Chairwoman; and,

WHEREAS, Texas has three voting members of the RNC – Republican Party of Texas Chairman Matt Rinaldi, National Committeeman Dr. Robin Armstrong, and National Committeewoman Toni Anne Dashiel – who are elected by the grassroots state convention delegates and accountable to the grassroots; now

**THEREFORE, BE IT RESOLVED**, the Republican Party of Bexar County (RPBC) expresses its dissatisfaction with the present leadership of the Republican National Committee (RNC) and their inability to address the concerns of the grassroots prior to the 2022 Midterm Elections; and,

BE IT FURTHER RESOLVED, the RBPC joins State Parties and County Parties across the United States of America in support of a leadership change at the RNC; and,

BE IT FURTHER RESOLVED, the RBPC urges the Texas voting members – RPT Republican Party of Texas Chairman Matt Rinaldi, National Committeeman Dr. Robin Armstrong, and National Committeewoman Toni Anne Dashiel – pay heed to the grassroots' expressed dissatisfactions and **vote for Harmeet Dhillon as the new RNC Chairwoman and Michael Whatley as the new RNC Co-Chair at the January 27<sup>th</sup> 2023 RNC mid-winter meeting in Dana Point, CA;** and,

BE IT FURTHER RESOLVED, if defeated, the Republican Party of Texas recognizes the contributions and services of Ronna Romney-McDaniels to the United States of America and the RNC, during her tenure; and,

BE IT FURTHER RESOLVED, The RPBC Chairman immediately makes public this resolution and forwards this approved resolution to the Texas voting members named above, ahead of the January 27<sup>th</sup> vote.
