# Republican Party of Bexar County Executive Committee August 25, 2024 Christian School at Castle Hills, 2216 N.W, Military Hwy, San Antonio

Chair Kris Coons called the meeting to order at 9:01 am.

### Invocation

Allen Hamilton, Precinct 3102, led the invocation, quoting Thomas Jefferson.

### Pledge of Allegiance

Dick Coons, Precinct 3030, led the attendees in the Pledge of Allegiance to the flag of the United States.

### **Texas Pledge**

Ginny Shannon, Precinct 2173, led the attendees in the Texas Pledge.

### **Determination of Quorum**

Republican Party of Texas (RPT) Rule 9 states at least one fourth of the membership shall constitute a quorum. There are currently 180 precinct chairmen so 45 members are required for a quorum. It was confirmed that 80 members were present.

#### Chairman's Remarks

Chair Coons updated the membership on the activities at headquarters the past couple of months. It has been a very busy time. We are thrilled there are 56 precinct chairmen to be approved today. This is critical since the precinct organization is the heart of the Party. The organizational meeting of the CEC and a successful car show were held. In addition, two Management Committee meetings, two Elections Training sessions, two Communication meetings, three Budget meetings, the Chair has met with all elected officials and most of the candidates, the recent open house attended by 140 people, the Trump/RNC Election Integrity training this week attended by 75 people, the very busy Trump Store are all ongoing activities. GOTV and voter registration is the priority.

### Approval of Minutes of June 29, 2024, Organizational Meeting

Diane Rath, Secretary, presented the Minutes of the Organizational Meeting of June 29, 2024. The minutes had been distributed to the precinct chairmen by email and Ms. Rath had two additional edits:

page 5, corrected Precinct 2 Caucus Chairman to Frank Fonseca

page 6, corrected spelling of Teresa Bollin's first name.

The minutes were accepted as corrected.

### **Ratification of Non-contested Precinct Chairmen**

The list of 52 individuals and the respective precinct that are uncontested was read and the candidates were introduced to the committee. (Attachment A)

Jennifer Hendrix, Precinct 3145, moved approval of the slate of uncontested precinct chairmen by voice vote. There were numerous individuals who seconded the motion. The motion was approved overwhelmingly.

With the ratification, there are 35 of the new precinct chairmen present, and the quorum is now 115.

## **Election of Contested Precinct Chairmen**

There are four precincts where two individuals applied to be precinct chairman. The candidates were introduced to the committee and invited to speak for two minutes.

Precinct 1152 – Alejandro Polanco and Gertrude (Trudie) Perez Precinct 3048 – Jonathan Delmer and John Hoyle, III

Precinct 3049 - Naomi Miller and David Ross

Precinct 3088 - James Burns and Dylan Young

Parry Gutting, Precinct 1108, raised a point of order reminding the Chair the newly elected precinct chairs could take their seats with the precinct chairmen. The new Precinct Chairmen moved to take their seats.

Robert Gonzalez, Precinct 2040, raised a point of order. One candidate for precinct chair was recently elected to the Bexar Appraisal Board. Is this individual eligible to serve as a precinct chairman? Chair Coons referred the issue to General Counsel Justin Nichols. Monica Rojas, Precinct 3082, provided Counsel Nichols the text of the Election Code addressing this issue.

Section 161.005 - Eligibility for Party Offices Generally(a) To be eligible to be a candidate for or to serve as an officer of a political party, a person must:(1) except as provided by Subsection (c), not be a candidate for nomination or election to, or be the holder of, an elective office of the federal, state, or county government; and(2) if the office is a county or precinct chair of a political party, be a qualified voter of the county.(a-1) For purposes of this section, the following are officers of a political party:(1) a precinct chair;(2) a county chair; and(3) a member, a chair, or a vice chair of a state executive committee of a political party.(b) For purposes of this section, a person becomes a candidate at the earliest time at which one of the following occurs:(1) the person files:(A) a declaration of intent to run as an independent candidate;(B) an application for a place on a primary or general election ballot or for nomination by a convention; or(C) a declaration of write-in candidacy; or(2) the person is nominated by a convention or executive committee.(c) A candidate for nomination or election to, or the holder of, an elective office of the federal, state, or county government is eligible to serve as an officer of a political party to which Chapter 181 applies.

Counsel Nichol stated the position of Bexar Appraisal Board is not on a primary ballot, and the candidate is therefore eligible to serve as a precinct chairman. Mr. Gonzalez stated he would pursue the information with the Secretary of State.

Chair Coons announced that a single ballot with all four races printed on it were being distributed to each member of the CEC. Each member may vote for one person per precinct in each of the contested races.

Chair Coons appointed Patricia Fagin, Teresa Bollin and Karl Merkyl as Tellers. The tellers collected the ballots and went to the back of the room to count the ballots. One watcher is allowed per candidate.

One additional precinct chairman has joined the meeting, so the quorum is not 116.

While the ballots were being counted, Steve Jordan, Precinct 3105, asked the Chair to explain the Sustaining Member Program. Chair Coons introduced Finance Chair Deana Abiassi who discussed the program and asked all precinct chairmen to join the program. Precinct chairmen who join today or increase their monthly contribution by \$10 per month will receive the cute hat worn by Chair Coons. The goal is to have 100% participation by all precinct chairmen. She thanked Ana Maria Farias for her in-kind donation of the gifts being used today.

Rick Briscoe, Precinct 3078, asked for a moment of personal privilege and discussed the importance of distributing educational materials to the voters in the precinct. He described what he has done in the past regarding printing, mailing, and educating voters in his precinct. He emphasized the importance of the Party providing materials to be used.

#### Introductions

While the tellers continued counting, the candidates and officeholders were introduced. During their remarks, Lille Gough, RPBC Treasurer and Budget Chair, distributed the proposed 2024-2025 budget.

\*Sylvia Soto, State Rep 124

\*Commissioner Grant Moody, Pct 3, represented by Misty Spears, who explained Commissioner Moody is on reserve duty this weekend. She reminded the membership he is the only conservative on the Court and raised the critical issue of the County's bond indebtedness. The per capita debt is the highest of any county in the country! \*Lina Prado, Commissioner Pct 1, was also represented by Misty Spears, who stated how important another seat on the Court is.

\*Congressman Tony Gonzales, CD 23, represented by Jake Bywaters

A door prize drawing was held.

The head teller returned and announced the results of the vote: Precinct 1152 – Gertrude (Trudie) Perez Precinct 3048 – Jonathan Delmer Precinct 3049 – David Ross Precinct 3088 – Dylan Young

Chair Coons asked all newly elected precinct chairmen to stand. She introduced Justice Lori Valenzuela, Fourth Court of Appeals, to administer the oath of office to the new precinct chairmen. She stated Justice Valenzuela will be re-elected once the first vote is cast in her election.

## Consideration and Approval of the 2024-2025 Budget (Attachment B)

Lille Gough, RPBC Treasurer and Budget Chair, presented the proposed July 1, 2024-June 30, 2025 budget. Ms. Gough recognized her committee members and others for providing valuable budget input. She stated she appreciated the assistance and support of the Budget Committee who reviewed and supported this budget. She stated the budget is the **goal** and is subject to change with circumstances. Since the draft had been distributed, she reviewed the categories and not the individual items.

Joe Leatherwood, Precinct 3181, seconded the motion.

There being no further discussion, the Budget was overwhelmingly adopted on a voice vote.

\*Chair Coons announced the Management Committee will meet at 9am on Sept 21 and the next CEC meeting is Sept 28 at Pica Pica Plaza. Breakfast will be available at 8am and the meeting will start at 9am.

\*She stated the RPBC Lincoln/Reagan Dinner will be October 25 at Sonterra Country Club. The keynote speaker is Governor Greg Abbott with special guest speaker Senator John Cornyn. Congressmen Roy and Gonzales, our state reps and Senator Donna Campbell have committed to attend.

\*Marian Stanko, Precinct 3015, announced a preview of the Reagan movie on August 27 at Alamo Drafthouse. It is a fundraiser sponsored by The Republican Club of Bexar County to benefit candidates. Tickets are \$75 and sponsorships are available.

\*Yvonne Clouser, Precinct 4057, Chair of the Trump/RNC Protect the Vote, stated this is President Trump's program and she emphasized the need for poll watchers and election workers. She is working with RPBC and will be at headquarters to work this program.

\*Monica Rojas, Precinct 3082, thanked Commissioner Grant Moody for providing the donuts for today's meeting.

\*Anita Kegley, Precinct 2134, announced the Church and Politics Meeting August 27.

\*Randolph Macias, Precinct 3036, stated he is glad to be back as a precinct chair \* Emily Nino, Precinct 1139, announced the Trump Train at 2:30 today.

\*Teresa Bollin, Precinct 1082, volunteer Coordinator, requested volunteers. Folks can call 210.824.9445 or complete the volunteer form on the website.

\*Marilyn Jowdy, Precinct 3180, urged opposition to the COSA city charter amendments and stated a resolution would be presented at the September CEC meeting.

\*Jennifer Hendrix, Precinct 3135, Coordinator of Precinct Organization, and Allen Hamilton, Precinct 3102, are conducting precinct chairmen orientation and training. The Chair reported 30 people attended the first orientation. She urged people to check the calendar on the website for information and events.

\*Curt Nelson, Precinct 3104, stated he is chair of candidate recruitment for the next election cycle and urged the members to be thinking of possible candidates. He will have more information at the next meeting. He emphasized the need for election clerks, judges, and workers for November.

\*John Austin, Precinct 3047, stated two committed precinct chairmen have passed away and asked for a moment of silence to honor Nancy Palmer and Barbara Miller. Chair Coons stated we would have a memorial for them at the next CEC meeting.

\*Vice Chair Kyle Sinclair, Precinct 1143, spoke about Attorney General Paxton investigating and executing search warrants against several individuals and the CGS company in Bexar County for 2022 election irregularities. He also spoke about the Mayor and Sheriff speaking at the DNC which should motivate us to be sure and get our friends out to vote. The Chair also urged folks to write letters to the editor discussing the difference in policies and actions of the two parties and candidates.

\*James Bush, Precinct 3201, urged folks to post letters to the editor on social media.

David Westbrook, Precinct 1107, moved adjournment. After one additional door prize drawing, the meeting was adjourned at 10:47.
